

# 2026 My EPIK Moment Video Event

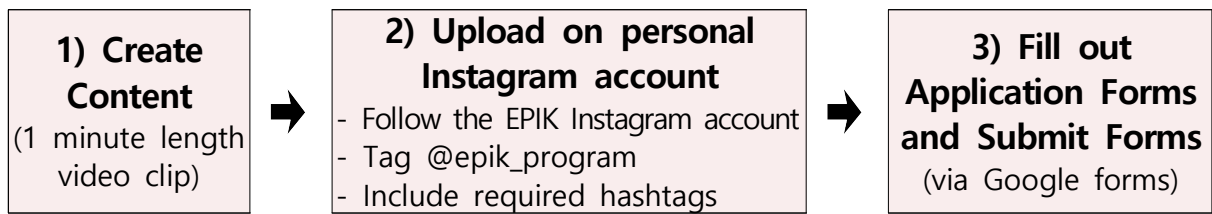
